### **Editorial Policies**

Plant Omics Journal (POJ) authors, editors, and reviewers come from around the globe. Submissions are accepted from all researchers around the globe. All papers should be submitted directly through POJ online submission and review system here: http://www.cropj.com/ri3/ojs3/index.php/POJ/login

Accepted papers must be of exceptional scientific importance and intelligible to a broad scientific audience. A POJ editor or section editor makes the initial decision for each submitted paper whether to go onto the review process or be declined immediately.

All articles are evaluated solely on their scientific merit by peers, not by professional staff editors. The review process for research reports includes an Editorial Board member and at least 2 independent-external peer reviewers. POJ Editors are professional scientists and active researchers. Direct is the preferred route for publication in POJ. Direct Submissions do not need to be sponsored by an editor member. Authors receive a first decision within 5 days, on average, and have their papers published online as soon as

4–5 weeks after acceptance.

Papers accepted for publication in POJ can be made immediately available online (Full Open Access) without cost to the reader.

#### **Journal Policies**

**1)** Articles are considered for publication if: they have not been **Published Previously** or concurrently submitted for publication elsewhere. Related manuscripts that are in press or submitted elsewhere must be informed in the cover letter (usually first page of manuscript file) during submission.

Figures or tables that have been published elsewhere must be notified, and permission of the copyright holder for both the online and print editions of the journal must be taken from publisher of work or editor of journal, in which the paper has been published. The permission must be submitted to the POJ editor, when authors are submitting the revised files (permissions not required during submission)

(2) Authorship must be limited to those who have contributed substantially to the work. The corresponding author must have obtained permission from all authors for the submission of each version of the paper and for any change in authorship.

The first and corresponding authors are mainly responsible for accuracy of results/data submitted for publication. However, co-authors have also responsibility for the entire paper as an accurate, verifiable report of the research.

An author may list more than one contribution, and more than one author may have contributed to the same aspect of the work.

(3) All authors, members, reviewers, and editors must disclose any association that poses a **Conflict of Interest** in connection with the manuscript. Authors must acknowledge all funding sources supporting the work. Recent collaborators, defined as people who have co-authored a paper or were a principal investigator on a grant with the author or member within the past 48 months, must be excluded as editors and reviewers. Other examples of possible conflicts include past or present association as thesis advisor or thesis student, or a family relationship, such as a partner or parent-child relationship. Please see the below for details.

(4) All work should be free of fabrication, falsification, and plagiarism as defined by worldwide accepted scientific communities.

(5) Completion of the online submission form electronically gives an exclusive license to publish the work to the

Southern Cross Publishing Group. If a paper is declined for publication, the license to publish is terminated.

(6) The journal may distribute copies of an accepted article to the main web site of journal prior to publication and before worldwide distribution by scientific counterparts.

(7) Although Plant Omics majorly publishes papers in plant biology, but researches involving **Human and Animal Participants** and **Clinical Trials** must have been approved by the author's institutional review board. Authors must include in the Methods section a brief statement identifying the institutional and/or licensing committee approving the experiments. For all experiments involving human participants, authors must also include a statement confirming that informed consent was obtained from all participants, or provide a statement why this was not necessary. All experiments must have been conducted according to the principles expressed in the Declaration of Helsinki. Authors must follow the International Committee of Medical Journal Editors' policy and deposit trial information and design into an accepted clinical trial registry before the onset of patient enrolment.

**(8)** Materials and Data Availability. To allow others to replicate and build on work published in POJ, authors must make materials, data, and associated protocols available to readers. Authors must disclose upon submission of the manuscript any restrictions on the availability of materials or information. Authors should include a statement in the methods section describing how readers will be able to access the data in the paper. Data not shown and personal communications cannot be used to support claims in the work. Authors are encouraged to use SI to show all necessary data or to deposit as much of their data as possible in community-endorsed publicly accessible databases, and when possible follow the guidelines.

Authors must make **Unique Materials** (e.g., cloned DNAs; antibodies; bacterial, animal, or plant cells; viruses; and algorithms and computer codes) promptly available on request by qualified researchers for their own use. Failure to comply will preclude future publication in the journal.

**(9) Databases:** Before publication, authors must deposit large datasets (including microarray data, protein or nucleic acid sequences, and atomic coordinates for macromolecular structures) in an approved database and provide an accession number for inclusion in the published paper. When no public repository exists, authors must provide the data as SI online or, in special circumstances when this is not possible, on the author's institutional website. Authors should contact the editorial office regarding special circumstances or privacy concerns.

**Protein and Nucleic Acid Sequences:** Authors must deposit data in a publicly available database such as GenBank, EMBL, DNA Data Bank of Japan, UniProtKB/Swiss-Prot, or PRIDE.

**Structural Studies:** For papers describing structures of biological macromolecules and small molecules, the atomic coordinates and the related experimental data (structure factor amplitudes/intensities and/or NMR restraints) must be deposited at a member site of the Worldwide Protein Data Bank: RCSB PDB, PDBe, PDBj, or BMRB. The PDB ID should be included in the manuscript.

Genomic and Proteomic Studies: Authors of papers that include genomic, proteomic, or other high-throughput data are required to submit their data to the NCBI gene expression and hybridization array data repository (GEO) or equivalent publicly accessible database and must provide the accession number. Access to the information in the database must be available at the time of publication.

(10) Figure Preparation. No specific feature within an image may be enhanced, obscured, moved, removed, or introduced. The grouping or consolidation of images from multiple sources must be made explicit by the arrangement of the figure and in the figure legend. Adjustments of brightness, contrast, or color balance are acceptable if they are applied to the whole image and if they do not obscure, eliminate, or misrepresent any information present in the original, including backgrounds. Questions about images raised during image scree ning will be referred to the editors, who may request the original data from the authors for comparison with the prepared figures. If the original data cannot be produced, the manuscript may be rejected. Cases of deliberate misrepresentation of data will result in rejection of the paper and will be reported to the corresponding author's home institution or funding agency. Authors must obtain consent for publication of figures with recognizable human faces.

**(11) Errata.** POJ publishes corrections for errors, made by the journal or authors, of a scientific nature that do not alter the overall basic results or conclusions of a published article. POJ articles may be retracted by their authors or by the editor because of pervasive error or unsubstantiated or irreproducible data. Articles may be retracted, for example, because of honest error, scientific misconduct, or plagiarism. Errata are published at the discretion of the editors and appear as formal notices in the journal.

# **Peer-Review Process**

The submitted manuscript will be initially checked be editor for quality, novelty and scientific merits. The editor will decided whether the manuscript should go to the peer-review process or to be declined immediately. This will take about one week. Authors whom their manuscripts have been declined will be notified by email within one week. If authors did not receive any notification within a week, this means that manuscript has gone through the peer-review process. The peer-review process will involve one editor and at least 2 qualified external peer=reviewers. The review process will take about 30-45 days. # **Conflict of Interests**

In the interests of transparency and to help readers to form their own judgements of potential bias, authors must declare any competing financial and scientific interests in relation to the work described. The corresponding author is responsible for submitting a competing interests statement on behalf of all authors of the paper. This statement must be included in the cover page (firs page) of submitted article file. The corresponding author will also be required to indicate the existence of a competing interest as part of the submission process.

## Human and Animal Rights

For articles in *Plant Omics* reporting experiments on live vertebrates and/or higher invertebrates, the corresponding author must confirm that all experiments were performed in accordance with relevant guidelines and regulations. The manuscript must include a statement identifying the institutional and/or licensing committee approving the experiments, including any relevant details, in the methods section.

For experiments involving human subjects, authors must identify the committee approving the experiments, and include with their submission a statement confirming that informed consent was obtained from all subjects. For clinical manuscripts that include identifying information relating to participants (including patients' details, images, or videos), written informed consent for their publication must be obtained from the participants or their parent or legal guardian. This documentation must be provided at the time of submission.

### License agreement and author copyright

*Plant Omics* does not require authors to sign a copyright for of their published original research papers to the journal during submission process. However, authors should be aware that submission of paper to Plant Omics Journal means that all right have exclusively been granted to publisher and authors are aware of all journal policy and also responsible for all the scientific accuracy and possible future damages which might be raised by any third party bodies or persons. Authors may be asked to sign and return a signed consent to publisher form later, when their manuscripts accepted for publication. The journal is fully open access Articles are published under a CC BY license (Creative Commons Attribution 4.0 International License). The CC BY license allows for maximum dissemination and re-use of open access materials and is preferred by many research funding bodies. Under this license users are free to share (copy, distribute and transmit) and remix (adapt) the contribution including for commercial purposes, providing they attribute the contribution in the manner specified by the author or licensor.
